**CERTIFICATION OF  
MIRYAM MALACHI**

MIRYAM MALACHI, being of full age, hereby certifies as follows:

1. I respectfully submit this Certification in support of my application for temporary restraints and preliminary injunctive relief against Defendants Avraham Appel (“Appel”), Robert Keleti (“Keleti”), and Chaya Rosenzweig (“Rosenzweig” and, together with Appel and Keleti, “Defendants”). Unless otherwise noted, I have personal knowledge of the facts set forth herein.

**A. My Introduction to Appel**

2. In 2019, I—then a single mother—was in significant financial distress and struggling to make ends meet for me and my children (L.M., now age 13, and M.M., now age 11).

3. When, in early 2020, I shared with M.M.’s former schoolteacher that I was having difficulty paying for M.M.’s daycare, the teacher suggested that I contact Appel.

4. According to M.M.’s former teacher, Appel was a trusted rabbi and pillar of the community who ran several charitable organizations, including Diversified Charities (“Diversified”), often counseled and assisted women in similar circumstances, and was a teacher at a religious private school—Kollel Cheshek Shlomo—that he owned and operated.

5. In February 2020, Appel met with me in person at a local Starbucks.

6. During that meeting, Appel presented himself to me as a rabbi, mentor, advisor, and friend, whom I could trust, confide in, and depend on.

7. During that meeting, Appel offered me the opportunity to solicit investments on behalf of his real estate business and its development projects because I had prior experience in commercial real estate.

8. Appel structured my compensation as a “draw” or advance against future commissions.

9. For example, between June 16, 2022, and July 17, 2022, Appel issued six separate payments to me that were characterized as advances or loans against future commissions and totaled \$20,000.

10. Upon information and belief, those payments were issued by Appel's charitable entity, Diversified.

11. Although the payments were characterized as advances or loans against future commissions and I am unaware of any deals for which I solicited investment funds that have closed, Appel has never requested that those funds be returned to him.

12. During the same period, Appel also provided Mrs. Malachi with financial "assistance" to pay for groceries and other necessities, such as medical expenses and water bills.

13. Upon information and belief, the financial "assistance" payments and/or donations were also issued by Diversified.

14. True and accurate screenshots confirming my receipt of payments from Appel/Diversified are attached hereto as Exhibit 1.

15. Regardless of how they were characterized by Appel and his charitable organization, it is now apparent to that the payments reflected in Exhibit 1—the most significant of which were made immediately after Appel sexually assaulted me on or about June 1, 2022—were part of Appel's calculated scheme to maintain power and control over me, keep me quiet, and take sexual advantage of me.

**B. The Sexual Assault**

16. On or about June 1, 2022, Appel came to my home at a time when he knew that I was alone and vulnerable because my children had already left for school and my then husband had been hospitalized.

17. During that visit, Appel forced himself upon me and sexually penetrated and contacted me, despite my clear and persistent cries that he stop (the “Sexual Assault”).

18. Appel was abusive and unrelenting. The more I pled for mercy, the more aggressive he became.

19. Before leaving, Appel insisted that I delete the Ring camera footage of him entering my home and supervised my undertaking of that task to ensure that it was done to his satisfaction.

20. Unfortunately, the Sexual Assault was not an isolated incident.

21. In the months that followed the Sexual Assault, Appel forced himself upon me and took sexual advantage of me on other occasions.

22. Appel also bombarded me with demands for sexual acts, along with a steady barrage of text and WhatsApp messages containing incredibly crude and graphic sexual content.

23. For example, Appel sent me a picture of himself along with messages saying: “I want to squeeze your breasts.”; “Lick your vagina dry.”; and “That’s the look you get before I flatten you.” A true and accurate copy of that message is attached hereto as Exhibit 2.

24. Appel likewise sent me a picture of his penis along with a comment about “sucking” it. A true and accurate copy of that message is attached hereto as Exhibit 3. I placed the image of the bucket over his penis after receiving the picture and before providing a copy to my attorney.

25. Upon information and belief, I am not the only victim of Appel’s sexual attacks and misconduct.

### **C. Appel’s Threats and Intimidation**

26. When I refused to be silenced about the Sexual Assault and other incidents, Appel threatened and intimidated me.

27. For example, Appel repeatedly threatened me that he knew people, including an inmate that had taken the fall for him in connection with another matter, who would “take care of” me if I disclosed any details regarding the Sexual Assault and his other conduct.

28. He also threatened that he would have me exiled from the community if I chose to speak to anyone regarding the Sexual Assault and his other conduct.

29. Appel likewise not only insisted that I treat with a therapist he recommended but also scripted exactly what I was to say to the therapist to get the help I needed to deal with the trauma he had caused me without revealing what had occurred.

### **D. Appel’s Attempt to Buy My Silence**

30. When the efforts to threaten and intimidate me appeared to be failing, Appel attempted to buy my silence.

31. In late 2024, Appel requested that my husband, Yehonatan Richenberg, and I meet with his attorney, Ian Goldman (“Goldman”), to discuss a “resolution.”

32. Goldman advised my husband and I that Appel was willing to make a lump sum payment of \$50,000 to cover my future therapy expenses if and only if my husband and I agreed to execute what was effectively a full release of any claims related to the Sexual Assault and keep all incidents involving Appel strictly confidential.

33. My husband and I vehemently rejected that proposal.

**E. Defendants’ Campaign to Destroy My Reputation and Lucrative Business Relationships.**

34. Soon after learning from my husband that I intended to pursue my claims against Appel in secular court, Appel, Keleti, and Rosenzweig launched a fierce and relentless campaign to destroy me—personally and professionally—and publicly vindicate Appel and Rosenzweig.

35. In fact, my former husband acknowledged in a text message to a close friend of mine, sent before the campaign began, that Appel had reached out to him to enlist his assistance in his plan to “take [me] down.” A true and accurate copy of that message is attached hereto as Exhibit 4.

36. In that same text exchange, my former husband acknowledged that Rosenzweig also had contacted him during the same period and similarly asked for his help in “taking [me] down.” *Id.*

37. As I first learned on December 15, 2025, Appel, Keleti, and Rosenzweig created a website with the domain address <https://malachichavala.com>, and which is titled “Beware of Miri Malachi/Maolem/Reichenberg” and subtitled “A DANGER TO KLAL YISROEL” (the “Website”). A true and accurate copy of the website is attached hereto as Exhibit 5.

38. It is my understanding that “Klal Yisroel” means, or is intended to mean, “Jewish peoplehood.” Thus, the subtitle of the Website effectively states that I am a “danger” to all Jews.

39. While the Website purports to “warn the public about this dangerous, individual [*i.e.*, Mrs. Malachi], and to provide a platform for victims,” it is based entirely on an array of patently false and defamatory statements, which I believe were curated and manipulated, in many respects, by Rosenzweig. Examples of those patently false and defamatory statements include the following.

40. The Website alleges that I stole funds I raised for the benefit of Binyamin Doyev and Tehila Recht—a couple for whom I hosted a wedding celebration at my house—stating: “She pocketed everything. Not one dollar when to them.” “She freakin’ stole the money. THIEF!”

41. As Mr. Doyev and Ms. Recht explain in their sworn certification, I did attempt to raise money to pay for the celebration in my backyard. But I was able to raise only \$2,000 through the campaign. My husband and I contributed our own money—\$8,000—to cover the balance of the cost.

42. The Website alleges that I blackmailed and extorted Appel (referred to on the Website as “the rosh kollel”) based on a completely tortured and distorted account of the relevant events between Appel and myself purportedly provided by a “relative” of Appel, which states, in relevant part, that:

My relative is a respected rosh kollel in Lakewood and a tremendous baa’l chessed. Miri started asking him for money about 4 years ago. She posed a poor single mother who couldn’t put food on the table. “I can’t pay my water bill, I can’t pay tuition, I’m gonna send them to public school . . . . I’m going to kill myself” [I saw the e-mails myself]. So he sent her money for utilities, therapy and tuition.

She then waited a few years and instead of saying thank you, tried to extort money from him making up all kinds of crazy allegations with “evidence” . . .

We have evidence that Miri had actually disclosed to someone 2 years prior to making up any allegations that she planned on blackmailing the rosh kollel and extorting money from. We were also made aware that askanim gave her thousands and thousands of dollars to help her deal with the “trauma” she experienced.

43. The Website further alleges that Mr. Richenberg sent Appel a text message threatening that he and his wife were going to “break the silence” if Appel did not pay them \$48,000 and purports to include a screenshot of that text chain.

44. As stated above, all the funds I received from Appel (through his charitable organization, Diversified) were understood by me to be “draws” in advance of future real estate commissions or gifts/donations to help me and my children with our financial needs.

45. In hindsight, I now believe that virtually every dollar I received from Appel and his charitable organization were solely intended to garner my trust, maintain control over me, lull me into a false sense of security, keep me quiet, and continue to take sexual advantage of me.

46. The statements concerning Rabbi Forscheimer are also patently false. While the Website states that I told Rabbi Forscheimer that I had “evidence” of Appel’s reprehensible conduct but refused to turn over my phone for a forensic screening, I met with Rabbi Forscheimer after I learned of the Website and Rabbi Forscheimer confirmed first-hand that he had never even spoken with me or my husband prior to that meeting, much less requested that I give him my phone for a forensic screening.

47. The allegation concerning the “blackmail” and “extortion” even goes so far as to attempt to vindicate Appel, knowing that a secular lawsuit concerning the Sexual Assault was forthcoming and trying desperately to get ahead of it:

As for the Rosh Kollole he was back in Bais Medrash the next day, through all the lies and evil. We admire his amazing will-power to move forward even when people whom he thought were close to him, and some who literally owe him their lives, turned against him.

48. The Website accuses me of stealing \$25,000 from Appel and states that I did so under the guise of considering suicide.

49. Once again, until only recently, the monies that I received from Appel were understood by me to be “draws” against future commissions or gifts/donations to help me and my family pay necessary expenses.

50. The Website falsely states that I routinely ask for money under various pretenses, such as needing it for my son's Bar Mitzva, and then uses that payment as "evidence" that she was paid for "services," and threatens to publicize that solicitation unless you pay me more.

51. I have never engaged in any such conduct.

52. The Website also contains a host of other accusations that could not possibly be more untrue and are solely intended to torment me and destroy my reputation, including, but not limited to, that (i) I "enjoy[ ] having affairs with married men" and have had "countless married 'boyfriends' in numerous places at the same time"; that (ii) I host parties involving "drugs" and dancing between "married and non-marrieds"; that (iii) I married my former husband solely to get my green card; that (iv) I failed to keep a kosher household; and that (v) I had a "revolving door of male visitors" while residing at 26 Green Cove in the Westgate apartment complex—a statement specifically attributed to Keleti, who was my immediate neighbor when I previously resided at that location.

53. The statement entitled "FAKER" reads:

I've never met anyone as slick nor as sick as her. She has hurt so, so many people. Everyone knows and everyone is afraid of her. No morals or dignity whatsoever. She doesn't pay for anything. She hasn't paid for tuition ever. Speak to Yeshiva Kol Torah directly they will tell you. She's a starving, single mom, has no money, but she lives in a mansion, has a live-in, travels the world, and just closed on a new construction custom house in **The Palm Estates** in Toms River. She is a total fake, through and through. Don't go for her. She is the most convincing person, can cry and scream and make you think you are the crazy one. **STAY AWAY!**

54. Upon information and belief, that statement was manufactured by Rosenzweig at the direction of Keleti.

55. The statement entitled “C. Story” is also directly attributable to Rosenzweig. It admittedly is a summary of the false claims that Rosenzweig previously asserted against me before a rabbinical court—the Beth Din—but could never prove.

56. The Website also discloses what should be my private address and solicits donations that will purportedly be used to fund the campaign.

57. As if the Website itself were not enough, Keleti has taken it upon himself to spread the message in every other possible way.

58. For example, Keleti has posted a link to the Website on his Facebook/Instaem page accompanied by the following message:

She used threats, false stories, and create[d] social media groups to shame and intimidate people who knew too much about her.

Private investigators were hired by people she threatened, and they found many others who had been harmed.

The community is urged to be very careful and to cut off all contact with this woman, this warning urgently to protect innocent people.

Her name – Miri Malachi Richenberg.

A true and accurate copy of that post is attached hereto as Exhibit 6.

59. Moreover, as evidenced by the screenshots attached hereto as Exhibit 7, Keleti (and possibly others) posted signs smearing me at public locations throughout the community, including the school that my children attend, and placed pamphlets and fliers of a similarly tortious message and tone on cars and in mailboxes throughout the area.

**F. Rosenzweig's Competitive Animus and Commercial Motives**

60. Upon information and belief, Rosenzweig is a licensed real estate professional and founder/owner of Rose Capital Group, a business that markets commercial real estate investment opportunities in Ocean County and other parts of the region to Israeli investors.

61. Rosenzweig competes directly with me in the solicitation of investments from Israeli-based and other investors in the very niche and tightly knit local Jewish community in which a person's name and reputation is critical to their success.

62. Upon information and belief, there is material overlap in our respective networks of investors.

63. Upon information and belief, Rosenzweig's animus toward and recent actions against me are driven by more than just our direct competition with each other.

64. Because of my experience with commercial real estate investments, members of the community who have invested monies through Rosenzweig and/or Rose Capital Group reached out to me and expressed concerns regarding those

investments because, among other reasons, there were inconsistencies in the stories the investors were being told and the de minimis distributions that some but not others who invested in the same property had received.

65. I researched what information is publicly available regarding those investments and identified what appeared to me to be causes for concern, including that one of the properties that had purportedly been acquired on behalf of the investors has been taken back by the original owner.

66. Upon information and belief, Rosenzweig is concerned that her investors are preparing to pursue claims against her in secular court and, like Appel, is using the Website and other components of the smear campaign to discredit the information that I have provided them and get ahead of their story.

#### **G. The Catastrophic Impact of Defendants' Actions**

67. The toll that Defendants' conduct has taken on me, my family, my reputation, and my business interests has been nothing short devastating.

68. The emotional trauma that I have suffered since the Sexual Assault and has now been exacerbated by Defendants' tortious and vindictive campaign is truly crippling.

69. Despite consistent therapy and a steady regimen of prescription medication, I cannot control my anxiety or panic attacks, the most recent of which occurred on Christmas Eve and which have become so intense and severe that they require emergency medical intervention.

70. Most days, I find it difficult to leave my home or accomplish even my most basic daily functions and chores. I also find it difficult—and sometimes impossible—to have sexual relations with my husband.

71. My husband and I are no longer comfortable in our own community and do not feel safe or secure in our home. In fact, we recently paid thousands of dollars to contractors to install an advanced security system and remove trees and shrubs that were obstructing our view of the perimeter.

72. Life for my children is no better. They, too, are ashamed to go to school and feel exiled when walking through their own neighborhood.

73. Their teachers have advised that L.M. and M.M. appear to be struggling, have been acting out, and are no longer themselves.

74. Defendants' actions have also ruined my professional reputation and lucrative business relationships and opportunities.

75. Over the years, I have built a network of Israeli-based and other investors and successfully solicited investment funds on behalf of United States-based real estate developers, including Sapphire Investment Group, LLC (“Sapphire”) and 15 Beaver Hill, LLC (“Beaver Hill”), which are both located in Ocean County.

76. Since the Website launched, two investors who invested in projects being developed Beaver Hill have demanded and received a refund of their investments—one for \$94,300, which was returned by wire dated December 18, 2025, and another for \$109,269, which was returned by wire dated December 23,


2025. True and accurate copies of those wire confirmations are attached hereto as Exhibit 8.

77. Similar requests for a return of monies have been made by multiple other clients who have invested approximately \$1 million through me.

78. It is only a matter of time before everyone asks for their money back and no one answers my calls.

I hereby certify that the foregoing statements are true. I am aware that, if any of the foregoing statements are willfully false, I am subject to punishment.

**CERTIFICATION OF

YEHONATAN RICHENBERG, being of full age, hereby certifies as follows:

1. I respectfully submit this Certification in support of Plaintiff Miryam Malachi's application for temporary restraints and preliminary injunctive relief against Defendants Avraham Appel ("Appel"), Robert Keleti ("Keleti"), and Chaya Rosenzweig ("Rosenzweig" and, together with Appel and Keleti, "Defendants"). Unless otherwise noted, I have personal knowledge of the facts set forth herein.
2. Mrs. Malachi is my wife under Jewish law.

3. When Mrs. Malachi and I learned in November 2025 that Appel was continuing to serve as a rabbi and hold his other positions of trust in the community in violation of the arrangement he made with Rabbi Joseph Rabinowicz (and other rabbis), I went to Appel's school on several occasions to confront Appel but Appel was not present.

4. When I went to the school on November 11, 2025, I was confronted by Rabbi Rabinovich (a different rabbi than the one mentioned above), who runs the school. Rabbi Rabinovich advised that Appel now had a new rabbi, Rabbi Pearl, advising him, and that Rabbi Pearl permitted Appel to start teaching again. In response, I told Rabbi Rabinovich that I was going to continue coming to the school until I had an opportunity to speak with Appel and that Mrs. Malachi is going to pursue claims against Appel in secular court.

5. When I returned to the school on November 13, 2025, there was security present. Rabbi Rabinovich told me to leave the premises or he was going to call the police.


6. On November 16, 2025, Appel's attorney, Ian Goldman, sent me a letter warning me to stay away from the premises of Appel's home and school and other businesses and organizations. A true and accurate copy of that letter is attached hereto as Exhibit 1.

7. The website appearing at malachichavala.com accuses me of extorting Appel for money and purports to depict a text message from me to that effect.

8. I never sent Appel or anyone else the text message depicted on the website or a message of any kind to that effect.

I hereby certify that the foregoing statements are true. I am aware that, if any of the foregoing statements are willfully false, I am subject to punishment.


8. Mrs. Malachi did not “pocket” any money related to that event and celebration.

2. In July 2024, I met with met Miryam Malachi and she shared with me evidence of Appel's inappropriate conduct toward her.



YEHONATAN RICHENBERG, being of full age, hereby certifies as follows:

1. I respectfully submit this Certification in support of Plaintiff Miryam Malachi's application for temporary restraints and preliminary injunctive relief against Defendants Avraham Appel ("Appel"), Robert Keleti ("Keleti"), and Chaya Rosenzweig ("Rosenzweig" and, together with Appel and Keleti, "Defendants").

Unless otherwise noted, I have personal knowledge of the facts set forth herein.

2. Mrs. Malachi is my wife under Jewish law.

3. When Mrs. Malachi and I learned in November 2025 that Appel was continuing to serve as a rabbi and hold his other positions of trust in the community in violation of the arrangement he made with Rabbi Joseph Rabinowicz (and other rabbis), I went to Appel's school on several occasions to confront Appel but Appel was not present.

4. When I went to the school on November 11, 2025, I was confronted by Rabbi Rabinovich (a different rabbi than the one mentioned above), who runs the school. Rabbi Rabinovich advised that Appel now had a new rabbi, Rabbi Pearl, advising him, and that Rabbi Pearl permitted Appel to start teaching again. In response, I told Rabbi Rabinovich that I was going to continue coming to the school until I had an opportunity to speak with Appel and that Mrs. Malachi is going to pursue claims against Appel in secular court.

5. When I returned to the school on November 13, 2025, there was security present. Rabbi Rabinovich told me to leave the premises or he was going to call the police.


6. On November 16, 2025, Appel's attorney, Ian Goldman, sent me a letter warning me to stay away from the premises of Appel's home and school and other businesses and organizations. A true and accurate copy of that letter is attached hereto as Exhibit 1.

7. The website appearing at malachichavala.com accuses me of extorting Appel for money and purports to depict a text message from me to that effect.

8. I never sent Appel or anyone else the text message depicted on the website or a message of any kind to that effect.

I hereby certify that the foregoing statements are true. I am aware that, if any of the foregoing statements are willfully false, I am subject to punishment.


